



Koppers Signs Five-Year Sales Contract With FirstEnergy

PITTSBURGH, PA, Jul 12, 2011 (MARKETWIRE via COMTEX) -- Koppers Inc. ("Koppers"), a subsidiary of Koppers Holdings Inc. (NYSE: KOP), and FirstEnergy Corp. ("FirstEnergy") have agreed to a five-year contract that begins June 16, 2011, and continues through June 15, 2016. Under the terms of the agreement Koppers will provide treated utility poles to FirstEnergy through its Railroad and Utility Products business at a total estimated value of \$20-\$25 million over the contract period.

Commenting on the contract, Walter W. Turner, president and CEO of Koppers, said, "We welcome FirstEnergy as a new customer, and we look forward to establishing a long-term relationship with their organization."
